

## Purple-To-Perfect Veterans Contest Official Rules

### NO PURCHASE IS NECESSARY TO ENTER OR WIN.

Purple-To-Perfect Veterans Contest ("Contest") starts on May 8, 2018 at 12:00 am Eastern Time ("ET") and ends at 11:59 pm ET on June 4, 2018 ("Contest Period").

**ELIGIBILITY:** Nominations can only be submitted by and for individuals who are legal U.S. residents residing within one of the eligible zip codes set forth on Exhibit A ("Delaware Valley"), and 18 years of age or older. Nominee must be a person who served in the active U.S. military, naval, air service or coast guard who was discharged or released under conditions other than dishonorable ("Veteran"). Nominee must own the home (e.g., house, condo, townhouse, apartment, co-op) in which they reside. For the purpose of these Official Rules, the "Nominator" is the individual who submits the nomination and the "Nominee" is the subject of the submitted nomination; both Nominator and Nominee may also be referred to herein as "participants." The Nominee must also be someone with whom the Nominator is personally acquainted, and Nominator must have Nominee's permission to nominate him/her. Individuals may nominate themselves, in which case Nominee and Nominator are one in the same.

Employees of New NGC, Inc., d/b/a National Gypsum Company ("Sponsor"), FOX Television Stations, LLC, on behalf of its television station, WTXF, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies, and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to participate. **HOW TO ENTER:** Visit [www.askforpurple.com/contest](http://www.askforpurple.com/contest) and follow the directions to submit a 250-word essay telling us about the Nominee, what room in the Nominee's home needs to be renovated (must include installation of walls) and why the Nominee deserves to win the Contest, and include three (3) photos showcasing the room and Nominee ("Nomination"). Only you, the Nominee (if applicable) and/or the individuals who live in the Nominee's home should appear in the Nomination. You must have permission to submit the Nomination from the Nominee (if not yourself) and anyone in the Nomination who is recognizable by sight or voice. If requested by Sponsor, failure to provide such permission in a form acceptable to Sponsor may result in disqualification.

Nomination must be in English. Nominations must be received by no later than 11:59 pm ET on June 4, 2018. Limit: The same Nominator cannot nominate the same Nominee more than one (1) time. However, a Nominator may submit more than one (1) Nomination so long as each Nomination is for a different Nominee, and a Nominee may be nominated more than once so long as each Nomination is from a different Nominator.

Sponsor reserves the right to allow for minor deviations from the guidelines and restrictions set forth herein, based on clear intent to comply with these Official Rules, as determined by Sponsor in its sole discretion. Nominations generated by script, macro or

other automated means or by any means which subvert the entry process are void. All Nominations become the sole property of the Sponsor and will not be returned.

Nomination must be your original work, must be true and verifiable, may not be obscene or inappropriate and must be in keeping with Sponsor's image, as determined by Sponsor in its sole discretion. Nomination must not have been previously published, must not have won previous awards, and must not infringe upon the copyrights (e.g., photos, artwork), trademarks (e.g., logos or slogans), rights of privacy, publicity (e.g., photographing people without a release) or other intellectual property or other rights of any person or entity. By submitting a Nomination, participant represents and warrants that the Nomination conforms to these Official Rules and understands that Sponsor, in its sole discretion, may disqualify the Nomination for any reason, including if it determines, in its sole discretion, that the Nomination fails to conform to these Official Rules in any way or otherwise contains unacceptable content as determined by Sponsor, in its sole discretion.

**USE OF ENTRIES:** By submitting a Nomination, participants hereby grant to Sponsor and its designees, successors and assigns a nonexclusive license to edit, modify, reproduce, distribute, display, perform, create derivative works based upon, or otherwise exploit the Nomination, together or separate from Nominator's and/or Nominee's name, cities and states of residence, images or likenesses, in any manner or media now known or hereafter devised throughout the world in perpetuity, for all legal purposes, including commercial, advertising, promotional and other purposes, without further compensation, notification or permission. Participants agree that Released Parties (as defined below) are not responsible for any unauthorized use of Nominations by third parties. Sponsor has no obligation to make use of the rights granted herein.

**PUBLICITY GRANT:** By participating, each participant agrees to the use by Sponsor and its designees, successors and assigns of his/her name, city and state of residence, image or likeness, in any manner or media now known or hereafter devised throughout the world in perpetuity, for all legal purposes, including commercial, advertising, promotional and other purposes, without further compensation, notification or permission, and to execute specific consent to such use if asked to do so. Winners may also be required to participate in media events and/or interviews.

**JUDGING:** All eligible Nominations received by Sponsor will be judged by a panel of qualified judges, selected by Sponsor, on the following criteria, with each criterion being weighted equally: Veteran's need for a room renovation, creativity of Nomination, and the ability to showcase National Gypsum's® PURPLE® brand high performance drywall ("Judging Criteria"), to determine the potential winner. In the event of a tie, an additional, "tie-breaking" judge selected by Sponsor will determine the winner based on the Judging Criteria. Sponsor reserves the right to not award the prize if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Nominations. All decisions of the Sponsor and judges are final and binding. Sponsor will not reveal the judging scores for any Nomination. For the avoidance of doubt, the Nominee and not the Nominator will be deemed the "winner."

**WINNER NOTIFICATION:** Potential winner will be notified by telephone, mail and/or email and required to execute an Affidavit of Eligibility and a Liability and Publicity Release (unless prohibited by law), which must be returned within five (5) days of date appearing on prize notification. If potential winner was nominated by someone other than

himself/herself, the Nominator may also be required to sign an Affidavit of Eligibility and a Liability and Publicity Release within the same time period.

Potential winner will be required to provide proof of home ownership, in a form acceptable to Sponsor. Potential winner may also be required to provide proof that he/she is a Veteran in a form acceptable to Sponsor. Potential winner may also be required to allow Sponsor to perform an on-site evaluation of the room to confirm the Nomination accurately represented the room and the need, as well as to confirm: (i) any necessary permits needed to conduct the room renovation can be obtained, and (ii) there are no structural, foundation or other issues that would impact a renovation, including, but not limited to, termites, asbestos or mold. Failure to submit to an on-site evaluation may result in disqualification and, at Sponsor's sole discretion, the prize may be awarded to a runner-up. If, as part of the on-site evaluation, it is determined that a renovation cannot be conducted for whatever reason, all within Sponsor's sole and absolute discretion, potential winner may be disqualified and, at Sponsor's sole discretion, the prize may be awarded to a runner-up.

Potential winner understands that Sponsor has partnered with WTXF to promote the Contest and that potential winner may be asked to participate in interviews, media events and/or potential winner may otherwise be featured in one or more stories on WTXF. **PRIZE:** Winner will receive a room renovation and GoPro camera, valued at approximately \$30,000. Actual value may vary based on final renovation of the room. Room renovation will take place approximately July 2018 to September 2018 and winner must be available and cooperative throughout the process during such time. The renovation will be overseen by a Sponsor representative and include all design, construction, labor, materials – including National Gypsum's® PURPLE® brand drywall products – plus décor items, appliances, furniture and paint as needed to complete the room for approximately \$30,000. Anitra Mecadon ("Designer") will visit the winner's home and work with a local contractor and design assistant to formulate a plan for the room renovation. Designer also will return to help put the finishing touches on the room. Winner understands that he/she will be permitted to have input on the final renovation but that all aspects of the renovation will be determined by Sponsor in its sole and absolute discretion.

Winner agrees to document the process bi-weekly with a GoPro camera received as part of the prize (“GoPro Footage”), photos and create bi-weekly blog posts (collectively, “Winner Materials”). Sponsor has no obligation to make use of the rights granted herein.
